1. **Call to Order** – Karen King called the meeting to order at 5:30 p.m.

Present - Board Members – President Karen King, Vice President David Schlangen, Treasurer Martin Daly, Secretary Ellen Smith, Matt Kohagen, Sandy Nirenberg, Gerry Olsen, Susana Reeder, and Christopher Valenzuela.

Absent: Thomas Kohagen
2. **Minutes** – The board unanimously approved the minutes of the March 4, 2020 meeting as presented.
3. **Next Meeting** – May 6, 2020 virtual meeting.
4. **Comments**
 - a. Ana Blattel reported that she had communicated with docents about vacancies on the CRF board.
5. **Unfinished Business**
 - a. Restructuring - The board considered whether the Camarillo Ranch Foundation should disband due to the denial of funding from the City of Camarillo or substantially restructure to eliminate Camarillo Ranch office services and focus solely on sustaining volunteer-led tours of the house for school children and the public. On a motion by Ellen Smith, the board took unanimous action in favor of restructuring rather than disbanding.

Discussion included concerns about how the restructured board would take on a host of responsibilities and fixed expenses with minimal income. Ellen Smith, Susana Reeder and other board members stated that they were extremely disappointed in the total lack of financial support offered by the City to support the work of the Foundation after the Foundation handed over all proceeds from

venue rentals to the City in good faith negotiations of the new Operating Agreement. Board members voiced concern that there is now no remaining funding source, after one-time reserves are spent, that is currently sufficient to sustain monthly fixed expenses into the future nor to address minimum administrative and fiduciary responsibilities of the Foundation including:

- Office administration - public communications, website, marketing, document management, legal postings, machine and service leases
- Docent Programs - school tour materials, set-up/clean-up of equipment, tour scheduling, fee collections and deposits, bus grant management
- Museum Programs - acquisitions, inventory maintenance, emergency procedures for protection of the collection, exhibit funding, maintenance of physical and digital archives
- Fiscal Management - fund raising, grant writing, banking, accounting, fiscal records, audits, production of Form 990 and other fiscal reports
- Risk Management - Insurances - errors/omissions and coverage of collection artifacts, emergency procedures, volunteer safety trainings and handbook updating
- Membership Program - cultivation and appreciation of donors, data base and donation management
- Coordination - ongoing communications with Command Performance and City of Camarillo on property sharing logistics.

6. New Business

- a. Retreat - The board took unanimous action on a motion by Susana Reeder to cancel the Board Retreat that had been scheduled for April 18, 2020
 - b. Board Member Applications - The board took unanimous action on a motion by Gerry Olsen to extend the deadline for new CRF board member applications until, Monday April 13, 2020 at 5:00 pm.
 - c. Fixed Expenses - The board discussed minimum fixed expenses needed to sustain the volunteer program including about \$2,500 per month for fixed fees/leases/insurances which does not include allocations for services such as secretarial, utility worker, accounting, audits or marketing. In addition there are annual costs of about \$3000 for school tour materials and bus grants to enable local Title 1 schools to visit the ranch.
7. **Closed Session** – Public Employee Discipline/Dismissal/Release Pursuant to Gov. Code 54957.6. Closed session was convened at 6:20 p.m. Open session was re-convened at 7:25 p.m.
 8. **Human Resources** - Karen King announced in Open Session that the board took action in Closed Session to give a 30 Notice to Command Performance to terminate contracted personnel services by April 30, 2020.
 9. **Adjournment**- Karen King adjourned the meeting at 7:27 p.m.
